GENERAL PAYMENT CONDITIONS FOR ALL PAYMENT OPTIONS:

- Families who pay the full course fee for the year before the start of the course or who pay termly will not be entitled to a refund if their child withdraws during the course of the term.
- An **enrolment fee** of **IDR 6,000,000** is payable to enrol a child. Should there be no places available and the family wishes to go on the waiting list, a waiting list fee of 10.000.000rp is payable for the next available place on the course. This is a down-payment on future fees and is refundable by 30 June 2022 should a place not come available for the new academic year.
- Students in serious breach of Pro Education policies will face removal from the course without refund.
- We encourage families to make an upfront yearly payment so that we can continue to plan and develop our program to the highest possible standard. Families who make an upfront payment may be eligible for a discount.
- When a payment is received late and not within the agreed timeline of payment plan, a surcharge of 500,000rp will be added to the total outstanding amount each week until the payment plan is up to date.
- A copy of transfer slip giving details of invoice number and student names should be sent to ProEducation when the transaction is made.
- All fees must be paid prior to the student commencing their course and net of bank charges.
- All payments are to be made to ProEducation by cash or bank transfer, online payment link, MasterCard and/or Visa Card.
- ProEducation does not charge a surcharge for using EFTPOS facilities.
- Our Policy states that all invoices need to be paid in advance for students to receive educational support unless otherwise discussed with the director of ProEducation Indonesia.
- If a family has paid for the school year / term in full and needs to leave Bali due to a COVID-19 reason their fees will be placed on hold. Our school's accounts department may pro-rata the time already used and place the remaining fees on hold. This ensures fees are not lost while a student is away. This payment circumstance is only valid during the COVID-19 pandemic.
- If a family has paid a year in advance and is currently outside of Indonesia and can't travel into Indonesia due to COVID-19 restrictions / visa restrictions, ProEducation may postpone the school fees to another school term. In this circumstance, the student place may be offered to another student. If the family arrives mid term and the place has been offered to another child, they will need to wait until the next school term. The fees may be postponed twice in the child's enrolment history.

MONTHLY PAYMENT POLICY

Some families may be able to apply for monthly payments if they meet the below criteria.

Families who are eligible for monthly payments must demonstrate with written evidence in a meeting with the school Principal the below:

- *They have been affected by the COVID-19 pandemic*
- *The family has lost more than 40% of their monthly income for a consistent period of 5 months or more*
- *The family has employment in the Tourism / Hospitality industry*
- *The family's primary earner has lost employment for more than 5 months*
- *The family can demonstrate they are heavily in debt and have other outstanding accounts*

The monthly payment plan incurs a surcharge of 10.000.000rp which is added to the current annual fees. The first installment is double the value of the remaining installments and acts as a bond to cover any possible late monthly payments during the year.

Families on a monthly payment plan are liable to complete the full termly payment schedule even if they withdraw from ProEducation prior to the school term ending.

Payments must be made according to the fee schedule agreed upon. If the individual defaults on payment and does not make payment consistently the child's place may be withdrawn.

TERMLY PAYMENTS

Families who pay by term follow the termly payment schedule on the school calendar. No discounts are applicable to termly payments.

YEARLY PAYMENTS

Families who have made the commitment to an upfront yearly payment receive a 5% discount on the tuition fee. This is a gratitude discount and is only on the tuition fee.

SIBLING DISCOUNT

A 5% discount is applicable on the tuition fee of an enrolled sibling.
